\*On Thursday, January 16<sup>th</sup>, of this week, we learned of a scheduled State of the Township Address at the Township Hall. Written invitations (see above) to this scheduled event had been extended to certain individuals. However, no advanced announcement of next Wednesday's scheduled event was made at the Board of Trustees meeting which we attended on Tuesday, January 14<sup>th</sup>, nor was there a posting inviting the general public to attend Supervisor Gonser's State of the Township Address. We wondered about this omission.

We solicited statements from both Supervisor Terry Gonser and new Township Manager Ann Capela. Ms. Capela responded with an assurance that "this event will be posted and public is welcome to attend." She further stated that the State of the Township Address was "organized

by Supervisor Terry Gonser in the same way as many Mayors/Supervisors/County Executives/Governors and other elected officials hold, usually at the beginning of a calendar year, to deliver a message about the state of 'their' community."

We welcome this opportunity to become better informed on the state of our township, and we strongly encourage all township residents to attend Supervisor Gonser's State of the Township Address on Wednesday evening at 7:00PM at the Township Hall.

According to Ms. Capela, this event will not be televised. Although a "volunteer" will be videotaping the Address, it is unclear as to whether that tape will be made available to citizens of the township.

## Moceri, et al, File \$4,000,000 Lawsuit Against Oakland Township – "Please Refund Our Water-Tap Fees"

According to a recent Oakland Press article, two lawsuits from builders and developers request that a judge require Oakland Township to refund the \$2500 water-tap fees that have been collected on new construction since 1998. The fees were intended to finance additional water lines to connect to Detroit Water System in areas where contaminated ground water was feared. In the Sept 10, 2013 Board of Trustees Meeting it was decided to stop collecting the fees as connection was unlikely. The lawsuits to refund the fees followed.

Oakland Township Sentinel plans to interview Township Officials in the near future to get their perspective on the story. What might be the effect on taxes? What happened to the original concerns about contaminated groundwater? What water supplies were these houses hooked up to?

## Detailed Discussion of Board of Trustees Meeting Agenda Items.

#### #4 – Announcements, Proclamations, Presentations

- Videos will be on website only 13 months due to space restrictions; after that they will be available from CMN TV – Supervisor Gonser
- Introduction of Ann Capela, new Township Manager Supervisor Gonser
- Dr. Atallah was awarded Certificate of Recognition for his one-year service to OPC. Dr. Atallah summarized advances made during that year. – Supervisor Gonser

#### #5 & 20 - Citizen Comments

Citizens can comment on any item not on the agenda at this point in the meeting or a second time at the end. Up until March of 2013, a summary of each citizen's comment was included as part of the minutes. In the March meeting, the Board voted to change their minutes to an "MTA short form". Now only the citizen's name and address are recorded, but nothing about what they said. Here we attempt to summarize citizens' comments:

#### #5 – Comments at beginning of meeting

Mrs. Beth Markel – Trails Millage, Fund 211 - reviewed her dissatisfaction with the large payments for professional services of \$238,000 while moneys spent on actual trail construction totaled only about \$33,000 since the inception of the millage. She likened it to paying \$700,000 to architects for a \$100,000 house. She said Parks Director Milos-Dale managed the fund as Trails planner and the Board approved all her requests.

We need to investigate what we actually received for our \$238,000. We have heard an overall survey of the potential of every trail on the Master Plan was part of this work. So to evaluate the value received for the \$238,000 we need to determine what all the deliverables were. We have entered FOIA OTS-2014-6 requesting this information. We will follow up with a report on this information.)

**Greg Olson** – glad to go on tour with ECT with regards to **Paint Creek Millrace restoration.** (Editor's note: Mr. Olson's home borders on the millrace. He and his wife Jan have been leaders of citizen efforts to restore the water flow to the millrace.)

#### #20 – Comments at end of meeting

#### Frank Ferriolo

- Boy Scouts could be likely volunteers for N0-Haz.
- Township board please encourage more citizen involvement in BOT and PRC (our two elected bodies) meetings to get more points of view. Consider using your "email blast" capabilities to alert people that "...there is a meeting tomorrow..." especially focus on Homeowners Association leaders who can relay the message to their association members. (Editor's note: Sign up on the Township website to have meeting notices sent to your email or by text message)

#### #7 - Bills - \$324,690 Approved

Bills totaling \$324,690.53 were approved as part of the Consent Agenda without discussion. Contrast that, with the detailed examining of invoices at the 1/8/14 Parks and Recreation meeting. PRC Commissioner and Treasurer Roger Schmidt questioned Parks Director Milos-Dale about \$160 for carpet cleaning, \$99 for contact security light battery replacement, and a \$550 legal bill. This can be seen starting at minute 180 of the Parks and Recreation Meeting tape for 1-08-14.

#### #9 – Selection of CPA firm for auditing services

After public interviews of three candidate firms, the Board selected Plante & Moran.

Some background and more detail:

Every year the Township must prepare a financial report, be audited, and send these reports to the State per this statute:

#### THE CHARTER TOWNSHIP ACT (EXCERPT) Act 359 of 1947

42.30 Annual audit of accounts; results, filing, public inspection; annual report of township business. Sec. 30.

An independent audit shall be made of all accounts of the township government at least annually and more frequently if deemed necessary by the township board. Such audit shall be made by qualified accountants experienced in municipal accounting. The results of such audit shall be on file in the office of the township clerk and available to the public for inspection. An

annual report of the township business shall be made available to the public by the township board in such form as will disclose pertinent facts concerning the activities and finances of the township government.

At the November 12, 2013 Board Meeting the Board authorized"...the issuance of an RFP by the Board for CPA services for The Charter Township of Oakland and to have Treasurer Langlois as coordinator of the issuance." In layman's terms, "they put it out for bid". The board felt that the Township had been using the accounting firm PSLZ, LLC for a long time and an RFP was appropriate.

#### #10 – The Myth Golf Course Golf Cart Parking Building – Site Plan Review

The Board approved the site plan that had been thoroughly reviewed and recommended for approval under Township ordinances by the Planning Commission, who had reports recommending approval of the site plan from:

- o Township Planning Consultant (Williams & Works),
- o Township Engineering Firm (PEA)
- o Township Environmental Consultants (ASTI),
- o Parks and Recreation Commission Subcommittee
- o Fire Dept.,
- o Building Dept.,

A function of the Planning Commission is to relieve the Board of a possibly tedious and technical review of building plans such as these.

## #11 – Mrs. Beth Markel – Freedom of Information Act Appeal (FOIA) Appeal

Mrs. Beth Markel entered an eight-page FOIA appeal asking for either more emails related to her request or a sworn affidavit from Parks Director Mindy Milos-Dale that what she was requesting did not exist. The Board voted to direct Township Manager to investigate and get written assurance from Director Milos-Dale.

#### **#12 - Community Block Grant**

#### #13 - No-Haz

Several times a year, if you pay a \$10 fee, you can take household hazardous waste to a nearby disposal site. To provide this service the Township Board must sign a contract (pages 69-85 in this meetings packet) with the county and provide volunteers who are coordinated by someone. Trustee Maureen Thalmann volunteered to be the coordinator, not a job anyone else was anxious to volunteer for.

#### #14 – Board of Review Appeal by Letter

The Board of Review meets with residents who appeal their property taxes for a variety of reasons. This was a routine but necessary decision to allow the appeal to be done by letter instead of meeting in person with the board. This accommodates people who cannot easily meet with the Board of Review, in person, for example if living in Florida, part-time.

#### #15 – Board of Review Hardship Guidelines

Laws allow the Board of Review to reduce property taxes for property owners with low income and low assets. Each year the guideline for income and assets are set. This year the guidelines are on pages 88-89 of the meeting packet.

#### #16 – Zoning Board of Appeals Alternate

Supervisor Gonser said an appointee is needed to be an alternate when some current ZBA members are on vacation early this year. This need will be communicated via the website. If interested you can apply with a self-nomination form found on the Township website.

#### #17 – Zoning Ordinance Amendment Funding

This item, to approve a proposal from Township Planning Consultants, Williams & Works was removed from the agenda. The reason is that the Board may consider other consultants for this work.

#### #18 – Lost Lake Caretaker

The Board voted to ask the Parks and Recreation Commission to review their proposed contract with new caretakers for Lost Lake Nature Park, Wombat, LLC. Board members concurred by this vote that they have primary responsibility to approve such contracts as they have various concerns including liability, tax accounting, etc. Supervisor Gonser said that repeated contacts with PRC on this matter had been ignored. The most recent contact was a January 7, 2014 letter from Township Attorney Dan Kelly to Parks and Recreation Attorney Steve Joppich (former Township attorney for many years before 2/26/13). Parks Commissioner Alice Tomboulian, who was present, disputed that, saying that they were complying with this new policy that had not been in force in the past.

#### #19 – Compensation Commission / Committee

Members of the Board of Trustees and various commissions have not had pay increases for as long as 12 years in some cases. Annual salaries go to only the Supervisor Terry Gonser (\$13,700), Clerk Karen Reilly (\$9,300) and Treasurer Jeanne Langlois (\$9,300). All other

members receive only a per meeting fee (per diem on the budget records) of around \$70-100 (Planning Commissioners, Zoning Board of Appeals Members, Historic District Commissioners, Parks and Recreation Commissioners.) Supervisor, Clerk, and Treasurer do not receive any per diem pay.

Pay can be changed by the Board in three ways:

- By direct action of the Board of Trustees
- By approval of the recommendation of a Compensation Commission appointed by the Board
- By approval of a recommendation an ad hoc committee created by the Board

The Board decided to delay decision on this matter.

#### **#21Board Reports**

#### Robin Buxar - Trustee

Commented on progress on millrace restoration project with ECT.

Had fun on the sledding hill recently; but got a big bruise – Terry Gonser's granddaughter was there as well.

#### **Mike Bailey - Trustee**

Commented on progress on millrace restoration. Said "The bottom line is we are making progress." Was complimentary of hands-on nature of the engineers from ECT. Said there will be another meeting at the site on Thursday. Trustee Buxar will fill in for him, as he cannot attend.


**Karen Reilly – Clerk** – no report

**Maureen Thalmann, Trustee** expressed her opinion that Parks and Rec is wasting money on legal fees by not using the same attorney as the Board of Trustees. Her verbatim comments, in total were:

"There's a subject brought up a couple of times this evening that I've done a little research on and I wanted to talk to residents about. If you remember, just less than a year ago we signed a contract with the law firm of Giarmarco, Mullins and Horton and who is aptly represented by Dan Kelly. And this was to be our township attorney going forward. They would handle the

normal litigation for or advice from conference calls. review correspondence, go over contracts. Litigation and labor information was going to be handled separately. But monthly we pay a fee and all the departments are able to use Mr. Kelly's expertise and the depths of lawyers within that firm. When that was decided, the Parks and Rec mentioned that they had some contracts they wanted to finish out using the prior attorney, Steve Joppich. And I was in full agreement with that. There was an amount set in the budget, contracts were going to be completed, and then their work would then go through Dan Kelly. Looking through invoices today, there have been eight (8) invoices that I found from Parks and Recs dealing with Mr. Joppich and his law firm and it now is up to seven-thousand and over six-hundred dollars. I'm not sure that the residents are aware that they are paying double for attorney coverage. I think it's very unusual for a department within a Township to have its own attorney. And I really don't think the taxpayers know that they are paying twice for attorney coverage. And I know I think I'm preaching to the choir a bit in this room, but I hope that the message gets out there and more residents are aware of this waste of money"


