Dear Michigan Local Government Committee members,

### Please **OPPOSE HB 4035!**

It compromises public safety and strips local governments of their authority to protect their residents.

Both the Michigan Municipal League and Michigan Township Association OPPOSE this preemption bill.

Waterford, Ypsilanti and all of the communities in Michigan that have them, want to keep their breed specific ordinances.

Shouldn't cities that enact breed specific ordinances be notified of their preemption bill for their input?

Local governments know best if their breed specific ordinance works in preventing serious (level 4-6) dog attacks. It should be up to the individual local governments to decide if Breed-Specific Legislation is affordable and enforceable for their jurisdictions.

## Federal Animal Welfare Act, (7 U.S.C. 54, AWA)

Michigan heavily regulates wolf-dog crosses and because of this legislation, Michigan residents have been kept safer.

In the last 13 years, **pit bulls have killed 314 people** compared to the wolf-dogs that have only killed a few.

Michigan weighed the interest of public safety against individual property rights and legislated in favor of PUBLIC SAFETY when it enacted the Wolf-Dog Cross Act. Michigan is discriminating against a type of dog breed in the interest of public safety. It makes sense that public safety should be the priority when legislating other dangerous dog breeds.

Why ban wolf-dogs, and instead protect the more dangerous pit bull? It defies logic.

"Hybrid owners could also assert that a ban violates their Due Process rights by depriving them of their property without just compensation. Determining whether a pet owner deserves compensation involves the use of a balancing test which weighs the **public's interest in safety against any harm which the owner may suffer.** Barring even the lack of an approved rabies

We have contacted most of the cities that have Breed Specific Ordinances. There have been zero level 4-6 dog attacks since they passed the ordinances. Breed Safety Legislation was only ever designed/enacted to reduce severe injury, catastrophic injury and deaths.

Anyone who fights BSL, because they are concerned about how it will affect their breed, is incredibly short-sighted. This isn't about them. It is about **preventing the mauling and deaths** of hundreds of thousands of people, pets, and livestock.

Communities have every right to feel safe. If one type of dog is committing a disproportionate amount of violence, then it is reasonable to take preventive action. Reactive laws mean someone gets hurt before anything is done.

"Punish the deed" is reactive and has proven to be ineffective. The owners of violent pit bulls file lawsuits to protect their maulers from euthanasia. The owners of violent pit bulls don't have insurance to pay the medical bills of victims. We know, the victim pays until bankruptcy then the taxpayer pays. The peaceful public pays the bills for pit bull advocacy and we have the right to expect better.

The purpose of a breed specific ordinance is not to prevent bites, but to prevent maulings. Bites require band-aids or a few stitches; maulings require amputation, plastic surgery, rehabilitation therapy, and possibly caskets. Supporting breed specific legislation will increase public safety, decrease pit bull breeding and decrease the number flowing into and being euthanized at shelters.
