Mr. Quesenberry,

You did not include Commissioner Blust's clarification in your email response. So my inquiry stands.

The cease and desist letter from Mr. Kline was obtained via FOIA and is publicly available on Bob Yaeger's website. If the PRC would like to improve communication with the public, knowing what is publicly available on the Oakland Township Sentinel would be a good place to start.

That letter clearly states:

“ It has also come to our attention you have indicated to the abutting Property owners a desire to meet to review future activities on the Property. You are hereby directed to not represent or take any action that creates the appearance of authority over Township owed property. Any statement regarding future activities on Property which have not been specifically authorized by the Board

of Trustees, will be considered a violation of this directive, which may result in disciplinary action. To be clear, you are not authorized to speak on behalf of the Charter Township of Oakland as it relates to any activities or the future plans regarding this Property.”

Most assuredly you are aware of this letter and it’s directives.

Any sensible interpretation of that letter is not that it broadly forbids an elected body from holding meetings, but rather instructs the parks and recreation department to cease and desist from discussing the “Fox Grant Property” at this time.

Clearly there is dispute about which body has ultimate authority over this township property. The surrounding adjacent property owners have been in communication and are aware of the directive.

It is my opinion that until it is established legally or otherwise who has ultimate authority, it makes most sense to hold off on any special meetings that would be in direct violation of what has been requested in Mr. Kline’s letter.

For this reason as I stated in my original email, the property owners are not planning on attending the meeting. Without our presence, the utility of such a meeting will be diluted.
