15.243 Exemptions from disclosure; public body as school district, intermediate school district, or public school academy; withholding of information required by law or in possession of executive office.

- (1) A public body may exempt from disclosure as a public record under this act any of the following:
- (h) Information or records subject to the physician-patient privilege, the psychologist-patient privilege, the minister, priest, or Christian Science practitioner privilege, or other privilege recognized by statute or court rule.

OPEN MEETINGS ACT Act 267 of 1976

15.268 Closed sessions; permissible purposes; applicability to independent citizens redistricting commission.

- (1) Except as otherwise provided in subsection (2), a public body may meet in a closed session only for the following purposes:
- (h) To consider material exempt from discussion or disclosure by state or federal statute.

OAKLAND TOWNSHIP CLERK'S DEPARTMENT RESPONDS TO FALSE CLAIM OF BALLOT ERROR

This afternoon (November 2, 2024), a current Board of Trustee member falsely accused Oakland Township Clerk's Department of incorrectly issuing a ballot to her, alleging that it had been mailed with an inaccurate precinct designation. In response, the department promptly initiated a thorough investigation.

We are pleased to report that the investigation has confirmed the claim to be <u>without merit</u>. To date, no other claims or complaints regarding ballot errors have been reported. Further out of an abundance of caution, the Clerk's Department did a full audit of all precincts and found <u>NO</u> discrepancies.

There was considerable controversy during the discussion about the appropriateness / legality of this message and the quality of the investigation where the Clerk's Department investigates itself.
