## **Blue Heron Environmental Area**

## New Trails, Parking, Picnic Area, Toilets, Observation Area Proposed

## Board to Vote on MNRTF Grant Application for at March 25<sup>th</sup> Meeting

Since the Parks and Recreation Commission (PRC) has determined that the Blue Herons have abandoned their rookery (nests) at this 139 acre park, they plan some improvements to allow more pubic access. Active recreation facilities such as ball diamonds, etc are prohoibited by a Convservation Easement held by Six Rivers Nature Conservancy.

Retired former PRC Director Mindy Milos-Dale has been retained as a Grant Consultant to prepare the grant application to Michigan Natural Resource Trust Fund (MNRTF) by the April 1 due date. (Revisions, after applying, can be made up to October 1.) Our Board of Trustees will be asked to approve the application at their March 25, 2025 meeting.

In a 2/27 planning workshop with 42 participants, some residents questioned if the herons have truly abandoned the nesting site and if so, could they be attracted back. PRC on 3/12 approved Dr. Ben Vanderweide's request to hire a consultant for \$250 to give them an updated expert opinion of this question (last exper opinion was in 2017). Blue Heron Environmental Area 3320 N Rochester Road Rochester, MI 48306

Purchased in 1990-91, the Blue Heron Environmental Area is quite possibly one of the Township's most unique parcels of land. The herons who give this park its name returned year after year. Great Blue Herons have not returned to the rookery since 2009. Nesting herons are very sensitive to disturbance within about 1000 feet of the rookery, including alteration of foraging areas.

The park contains 139 acres of wetlands, highquality lowland forests, and open farmlands along Rochester Road between Gunn and Buell



Roads. Fields are leased to local farmers at this time. Oakland Township residents may contact the Parks and Recreation Commission office to arrange for regulated access to the critical wildlife habitat at this park.
