These minutes do not adequately explain what took place for someone who did not study the packet and attend the meeting or watch the video. I will try to add more explanation, so you don't have to do that, although it is recommended.

#### From the draft minutes for agenda 1 -

1. Consideration of authorizing PEA Engineers to complete the contract for the design, engineering, and production of bidding documents for the East Snell Road safety path and authorize the expenditure of up to \$110,000.00 in additional funding.

This agenda item was tabled.

#### Sentinel added comments.

I would say that the biggest and potentially most controversial item at March 11 meeting was the estimated \$1,500,000 sidewalk east on Snell Road from Rochester Road to the 4435 acre (6.9 square miles) Stony Creek Metropark and through that Park and back across Snell to our fairly new 268 acre Stony Creek Ravine Nature Park.

The Safety Path and Trails Committee proposed approval of \$110,000 to pay for enough detailed engineering to lead to bids for this sidewalk. Some, (including me) have safety concerns about crossing Snell Road twice enroute to Stony Creek Metropark. I prefer a route that goes down Sheldon. Another option is a path from the end of the cemetery sidewalk to Sheldon and turn right on Sheldon and go all the way to Meade, connecting to Rochester Hills safety paths. No decision was made. Not shown in the minutes is that Manager Joe Merucci was asked informally (no motion) by our Board to get clarity on what exactly Stony Creek Metropark is committing to build connecting to the proposed sidewalk. As this is not on the agenda for March 25, perhaps this clarifying is not yet complete. Or maybe SPTC will reconsider at their April 2 meeting?

RE: Comcast Broadcaster and Fiber upgrade quote

As you are aware, we have been working with Chris Weagel (CMNTV) and Comcast since mid-2024 on a quote to upgrade our Broadcasting hardware at Township Hall. Several residents have raised concerns that watching meetings on Television is not acceptable due to bad audio and video quality. Chris Weagel has confirmed that our Broadcasting hardware is out of date and cannot handle the bandwidth that our video equipment produces also the connection is insufficient. Chris has been working on upgrading all the communities that utilize CMNTV. The videos online are high-quality, but when watching live on TV the videos are inferior quality.

#### Background:

We currently receive Cable franchise fee revenue from Comcast and Direct TV which is not restricted in the amount of about \$300k a year. We also receive a PEG fee from Comcast and Direct TV, (Public, Educational, Government) which is restricted and may only be used on expenses related to broadcasting. The restricted account is how we pay for CMNTV's services and capital expenses for our broadcast room and Board Room. The current balance in our restricted account is \$101,310.74, we typically add about \$30k each year to this fund in PEG fees, and we spent about \$20-30k a year on broadcasting fees with CMNTV. Over the years the restricted balance has averaged around \$100k.

#### Estimate:

Cost estimate to install the fiber line \$32,581.49
Cost estimate for the hardware \$2,910.00
Total estimate to upgrade Oakland Township's Broadcasting ability - \$35,491.49

#### Recommended Motion:

A motion to approve budget amendment #25-08 to transfer \$36,000 into account 101-901-980.747 EQUIPPURCHASE – WEBCAST/CABLE from restricted Fund balance and to approve Comcast to install the fiber line and the hardware needed in the amount not to exceed \$36,000.00 4. Consideration of participating in the Oakland County Road Commission 2025 Gravel Haul Program.

Motion by Mabry, seconded by Elder to approve Oakland Township Participation in

the 2025 Gravel Haul Program with the anticipated spending in the amount not to exceed \$336,000.

Motion amended to increase the amount not to exceed \$340,000.

Both of these are for roads. There is supposedly a "plan" for adding gravel to roads in rotation. When I tried FOIA a year ago, there was no plan, at least not in writing. Board members discussed this as though there was and in fact requested that information on adherence to the plan.
